 - A. O'Neil explained:
 - CAC received \$1,000 for the Lucy Funke scholarships; Network for Good; small amounts from individuals
 - Willard Foundation Received 2 checks; first is for \$9,000 and second is for \$12,000.
 - Mottz Received \$10,000.
- Expenses In-line; where expenses are expected to be at this time.
 - Highlights/Discussion:
 - Row 6187: DRI; \$42,672.98 was refunded by NBT Bank.
 - V. Lee inquired about expense for class and workshop instructors. Discussed how M.B. Miller secured a grant for the workshops.
 - R. Fuller reported that interest was higher; considered when budgeting.
 - Performances: One more show within this fiscal year; some show covered by grants
 - No more large expenses forecasted for the remainder of this fiscal year.
