- Revenue \$88,000; just under 50% of budget
  - Area to Drive Revenue- Ticket Sales, Membership, Workshops Encourage participation of friends and family
    - Can improve ticket sales at \$4,400; just at 19% of budgeted income
      - Getting people to shows help encourage continued corporate support
- Expenses (Bottom up); just over 50%
  - Based on timing
  - o Payroll same
  - Performances Timing; not to worry
  - o Rent Paid June rent in July; paid November rent already
  - Legal/Professional Fees Just above budget; is going to go up each year
